### TRACK RECORD

As lead counsel for a trust beneficiary in a dispute against the trustee, compelled and tried a contested trust administration issue related to the California Principal and Income Act to a three-panel arbitration and secured over US \$700k for the client.

Served as lead trial attorney in successful bench trial, representing trust beneficiary against co-trustees for breach of fiduciary duty resulting in \$6.4 million judgment.

Obtained restraining order on behalf of an elder to stop ongoing financial abuse by one of the elder's children and appointed a support team to protect the elder and ensure the elder had financial assistance
