Adeline has a broad commercial practice. She has acted at all levels of the Singapore courts in matters involving complex and/or multi-party commercial litigation. Her practice spans various areas, such as banking and finance, shareholders' disputes, contractual disputes, fraud, trusts, unjust enrichment, and jurisdictional matters (conflict of laws). She has also advised on, and represented, individuals and companies in criminal matters arising from commercial transactions and in disciplinary proceedings. Apart from accepting direct instructions from clients, she also acts as instructed counsel.

Since being called to the bar in 2017, Adeline has argued, as lead counsel, a wide range of interlocutory matters in civil proceedings in both the High Court and State Courts.

She is an active volunteer with the Criminal Legal Aid Scheme and was appointed, in 2019, as a Junior Assisting Counsel under the Legal Assistance for Capital Offences panel of lawyers. In 2020, she was appointed a member of the Law Society of Singapore's Criminal Practice Committee.

Adeline graduated with a First Class degree in Law from the University of Nottingham, and was awarded the Punch Coomaswarmy Prize by the university. Adeline also regularly represented the university in advocacy competitions. Prior to reading law, she obtained an honours degree in Accountancy and practiced as an auditor in a Big 4 accounting firm.

### TRACK RECORD

Acted for a professional in the financial services industry in a S\$17 million contractual dispute. Successfully led an interlocutory application for amendment to pleadings. This decision was later upheld by a High Court judge sitting in chambers, and by the court of appeal.
